## Incentive Request Form

**To be eligible for the allowance, you must meet all the requirements below:**

\*Active members include active duty (including activated Reservists) of the U.S. Air force, Army, Navy, Marines, National Guard, Coast Guard, Veterans Administration and those who have recently finished active service (within 6months) with a current military identification card or are a key military contractor. A copy of DD form 214 may be necessary for those who recently have been discharged from active service. Box 1227 Westwood, NJ 07675-1227 - Attention: BMW Motorrad USA Sales Department).

**Purchase Terms**

Purchasers are eligible for one (1) Military Purchase allowance during the program calendar year (January 1, 2010 through December 31, 2010). Motorcycles purchased and reported under a name other than the eligible military program applicant do not qualify. Sales documentation, registration and claimant ID must match. This allowance may be combined with any other retail customer incentive\* available at the time of purchase for a qualified model, which is defined as any new, previously unregistered BMW motorcycle sold between the dates of January 1<sup>st</sup> through December 31<sup>st</sup>, 2010. BMW Motorrad fleet or auction units do not qualify! \* May not be combined with Center Employee Purchase Program, BMW MOA / BMWRA / VBMWMO Club Offers, Emergency Services or Vendor Purchase Programs. Motorcycles must be purchased through an authorized BMW Motorrad USA dealer. Purchases through a 3<sup>rd</sup> party or BMW dealers outside the USA are not eligible. Applications must be submitted within 60 days of the date of delivery to be eligible for this program. Retain proof of submission for your records – BMW is not responsible for failure of claim form or contents to be received by BMW.

BMW Motorrad USA reserves the right to make changes to the Program and/or terminate the Program at any time without prior notice. All claims are subject to audit. In the event of improper reporting or other program-related improprieties, BMW Motorrad USA reserves the right to recover payment.
